1. Making a reservation

- Ensure that all the details on the reservation are complete and correct before confirmed.
- We will not be held liable for any inaccuracy's in data.

- Once the reservation has been accepted a confirmation email will be sent to the email address that has been provided on the reservation.
- If you believe that there is an error on the reservation, please contact us immediately to amend and correct.

2. Group Bookings

- Any bookings for 5 or more apartments will be classes as a group booking. You and the members of your group must not resell the reservation in full or in part.
- You are not to advertise, market or otherwise offer any Urban Creation Ltd Apartment.
